Proceedings of a Park County Board of County Commissioners special meeting, held in Cody, Wyoming on Tuesday, July 22, 2008. Present were Commission Chair Tim French, Commissioners Bill Brewer, Marie Fontaine, Jill Shockley Siggins and Bucky Hall and County Clerk Kelly Jensen.

**Park County Complex Fiber Optics**

Chief Information Technology Officer Mike Conners and Park County Attorney Bryan Skoric presented information to the Board relating to the agreements by Eleutian Technologies and TCT West to provide fiber optics to the Park County Complex building. No action was taken.

**Budget Approval**
