## General Purpose Sales & Use Tax at a Glance...

- Often referred to as the 5th cent tax or the 1% optional tax.
- · Limited to a specific time period.
- Does NOT apply to real estate purchases, fuel, food sales for home consumption, farm equipment and 45 other types of purchases.
- Goes away in four years if not renewed by voters.
- The State has made the 5th cent available as a means to increase revenue and 21 of 23 counties have approved the 5th cent tax.
- The Wyoming counties and municipalities that have approved the General Purpose Sales & Use Tax ("5th cent tax") have used these funds to address many important efforts:
- Repair & Maintenance of Streets, Roads, Bridges, Water & Sewer Mains
- Water Treatment Plant Maintenance
- Senior Center Operations & Maintenance
- Senior Programming
- Police & Fire Services / 911 Emergency Support
- Public Works Equipment & Facilities
- Community Transportation Programs
- Library Operations & Maintenance
- Museum Operations & Maintenance
- Fairgrounds Operations & Maintenance
- Recreation Center Operations & Maintenance
- Parks & Pathways Maintenance & Upgrades
- Mosquito Abatement
- Town Beautification
- Other Operating, Capital Improvement & Community Program Needs



## 14 Tax Facts You Should Know. A Guide to Wyoming's Sales & Use Taxes.

- The State of Wyoming has a general 4% sales tax that applies to all 23 counties.
- 2 Local governments keep 30% of the 4% sales and use tax revenues. The State of Wyoming keeps the other 70%.
- The existing 4% sales and use tax funds make up about 17% of Park County's general fund, 37% of Cody's general fund, 30% of Powell's general fund and 23% of Meeteetse's general fund.
- Because local governments get less than one-third of the existing 4% sales and use tax revenues, many counties and municipalities have sought voter approval of a General Purpose Sales & Use Tax. In fact, 21 of Wyoming's 23 counties currently have a voted-in General Purpose Sales & Use Tax. (known as that "5th cent").
- The average household income in Park County is \$50,000. Based on a formula provided by the State of Wyoming Office of Economic Analysis, from a report titled *Tax Rates and Tax Burdens* (dated November 2014) the AVERAGE impact of an additional 1-cent sales tax on a \$50,000 household income would be \$80/year.

- The 5th cent tax is an additional 1% tax. For example, on a \$10 purchase, the tax is 10 cents. On a \$100 purchase, the tax is \$1.00.
- **7** Local governments get to keep 99% of a voter-approved 5th cent tax.
- Revenues from a voter-approved 5th cent tax are distributed based on population. For example, if Park County voters approved a 5th cent tax, the revenues would be distributed as follows: 43% to Park County, 34% to Cody, 22% to Powell and 1% to Meeteetse.
- A voter-approved 5th cent tax would generate about \$7 million for Park County and its municipalities annually (\$3 million for Park County, \$2.4 million for Cody, \$1.5 million for Powell and \$100,000 for Meeteetse). This is almost as much revenue that the County and municipalities get from the existing 4% sales and use tax.
- There are 49 exemptions from the 5th cent tax, according to State Statute 39-15-105, including real estate purchases, food, fuel, fertilizer and farm equipment.

- According to the Wyoming Department of Tourism, it is estimated that about 30% of a voter-approved 5th cent tax in Park County would be paid by travelers from outside Park County.
- Property taxes fund a relatively small percentage of the general funds of our local municipalities in Park County. In fact, only about 6.5% of Cody's and Powell's general fund is derived from property taxes. In Meeteetse, this amount is even lower at 2.8%.
- The 5th cent tax (General Purpose Sales & Use Tax) would have a four-year sunset in Park County. The 5th cent tax would be voted on every four years.
- Revenue from a voter-approved 5th cent tax would include sales taxes generated inside Yellowstone National Park.
